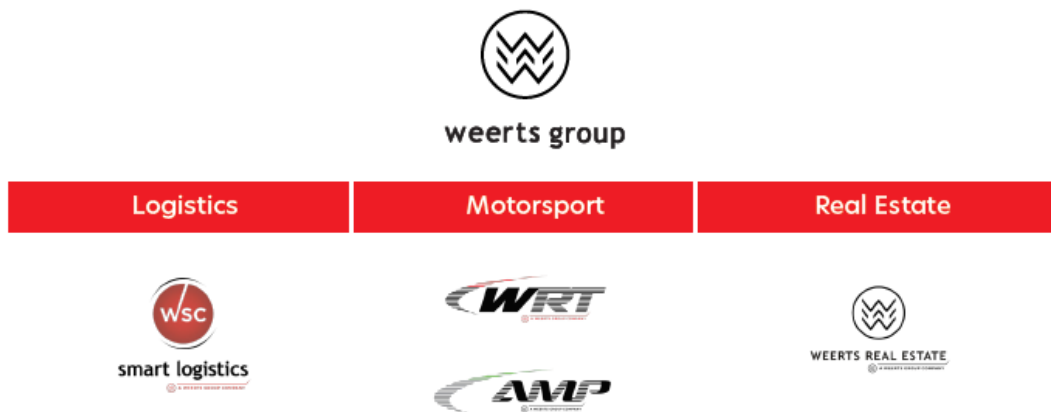




## ABOUT WEERTS GROUP
